Report from the North American Regional Science Council

This year's North American Meetings of the RSAI were held in Savannah, GA. Concerns that this location would not be attractive to conference visitors turned out to have been wrong. Attendance was excellent, comparable to the record attendance in Toronto the year before. The quality of the presentations was very high and the city was also a pleasant and beautiful place to visit.

The North American Regional Science Council met on Wednesday, November 7, 2007. The councilors voted to make the 2007 Walter Isard Award to Brian Berry, University of Texas at Dallas, and to Larry Brown, Ohio State University. Randy Jackson, West Virginia University, was recognized with the David Boyce Award for service to regional science. Some of you may not be aware that for many years Randy has maintained the web pages of the RSAI. This task will now be turned over to a professional office in Great Britain, at the location of the current RSAI headquarters. Randy and the Regional Research Institute at West Virginia University will continue to maintain the SRSA web site. Finally, the Hewings Award, which honors an up-and-coming young scholar, went to Gilles Duranton of the University of Toronto.



This item is a follow-up from the report published in Summer 2007. The councilors passed the resolution for NARSC to join with colleagues and regional science associations from Latin America to form the Regional Science Association of the Americas (RSAmericas). NARSC will continue to function as it currently, except that its vote on the Regional Science Association International (RSAI), our global umbrella organization, will be turned over to the RSAmericas. To reflect the changes, the NARSC constitution was revised.

Roger Stough presented a summary of efforts to strengthen regional science world-wide by assisting with the formation of national associations. For example, the PR China already has a large association, but it is not currently affiliated with RSAI, something that both the Chinese colleagues and the RSAI would like to change. The South African RSA is experiencing some stagnation and difficulties, after a promising start a few years ago. Representatives from the RSAI will see what can be done to assist. Roger Stough also informed us that once the RSAI achieves a membership of at least 5,000, it will be recognized by the United Nations as a non-governmental organization to be consulted by UN bodies on policy issues in RSAI's areas of expertise.

Next year's North American meetings will be held on New York on November 20-22, 2008. The New York Marriott at the Brooklyn Bridge is the conference hotel. Bill Anderson is chair of the program committee, and Michael Lahr and Andrew Haughwout are serving as local organization committee co-chairs. The 2009 meetings will be held in San Francisco and the 2010 meetings will be in Denver.

Bruce Newbold was elected as the new NARSC chair and Vernon Henderson as the new NARSC president. The North American representatives to the RSAmericas will be James LeSage, Maureen Kilkenny, Edward Feser, Mario Polèse, and Jean-Claude Thill. Terry Clower was selected by RSAI and ratified by NARSC to serve as North American Editor of the new RSAI journal Regional Science Policy and Practice (RSPP).
